Your reference list should be ordered alphabetically by author and then chronologically by year of publication. The APA 6th style requires the references to be indented as illustrated below in the examples. For instances of multiple articles with the same authors and years of publication, please check the APA publication manual or Academic Writer. If you have the DOI for the journal article, you should include it in the reference, otherwise, it is not necessary.

Before this edition, an issue number was only added if the journal paginated each issue starting with 1. Now, all issue numbers should be added, unless the journal or database does not assign them at all. In that case omit this element. A journal article reference entry in APA 6 format: Plessis, T. du.
