A food worker certificate is required for any person who handles, prepares, serves, sells or gives away food for human consumption, including those whose duties are restricted to busing or washing dishes. New food workers must obtain their certificates within 30 days of hire. The certificate may be obtained by doing one of the following:

STUDY GUIDE FOR THE FOOD SERVICE WORKER EXAM

Successfully complete the requirements for a food worker card renewal (attend the food safety training and pass the exam). Have proof of successfully completing " additional food safety training " within 2 years prior to the food worker card renewal. (For example, if the renewal card is issued on 3/1/2020, then the "additional food safety training" must have been completed on or after 3/1/2018.)

To receive a certification, you must first complete the free Online Food Protection Course, or pay to attend the virtual classroom course. The online course is offered in English, Spanish and Chinese. The course is self-paced and consists of 15 lessons. You must complete each lesson and pass a quiz before moving on to the next lesson.

Food Worker Cards Alaska regulations require food workers to obtain a Food Worker Card within 30 days of employment. Food Workers in the Municipality of Anchorage (MOA): The MOA issues their own food worker cards. Cards issued by the State of Alaska are not valid in the Municipality of Anchorage.
