How to Cite Sources | Citation Examples for APA, MLA ...

Go to 7th edition guidelines. Use secondary sources sparingly, for instance, when the original work is out of print, unavailable through usual sources, or not available in English. Give the secondary source in the reference list; in text, name the original work and give a citation for the secondary source. For example, if Allport's work is cited in Nicholson and you did not read Allport's work, list the Nicholson reference in the reference list.

How do you cite a source that you found in another source ...

If your sources are very important to your ideas, you should mention the author and work in a sentence that introduces your citation. If, however, you are only citing the source to make a minor point, you may consider using parenthetical references, footnotes, or endnotes. There are also different forms of citation for different disciplines.

To cite paraphrased material in the text of your paper, put the author's last name in parentheses at the end of the sentence where the paraphrase appears. Place a comma after the author's name, then type the year the source was published. Place the period ending

In order to make it easier for a reader to navigate your essay and look for cited sources, there are specific rules to follow to organize it: First, the reference page is always the last page in your essay. At the top of the page, place the word "References". Do not make it bold or underline it.

Sometimes an author of a book, article or website will mention another person's work by using a quotation or paraphrased idea from that source. (This may be called a secondary source.) For example, the Kirkey article you are reading includes a quotation by Smith that you would like to include in your essay. The basic rule is that in both your References list and in-text citation you will still cite Kirkey.

An in-text citation is a citation within your writing that shows where you found your information, facts, quotes, and research. All MLA in-text citations require the same basic information: Author's last name (no first names or initials) Page number (if available)
