The consultant must be a resident of Iowa; hold a certification in Category 11, Aerial Application; and either a valid commercial applicator license or pesticide dealer license. An applicator certified in Category 11 also may apply pesticides by non-aerial methods as described in Categories 1A, 1B, 1C, and 1D.

Atrazine is a restricted use pesticide due to ground & surface water concerns. Atrazine application rates are limited to 2.5 lbs per acre per calendar year; restricts rates to 1.5 lbs in 23 counties (7 county -wide 16 in some townships); may not be mixed, loaded, or repackaged within 50 feet of a sinkhole, well, cistern, lake, water impoundment, this includes, but is not limited to, abandoned ...
