An underground storage tank (UST) system is a tank and any underground piping connected to the tank that has at least 10 percent of its combined volume underground. The Office of Land Quality (OLQ) does not regulate every type of storage tank. OLQ regulations apply only to UST systems that store petroleum or certain hazardous substances.

"Underground storage tank (UST)" - any one or combination of tanks, including pipes connected thereto, which is used for the storage of petroleum and which is substantially or totally beneath the surface of the ground.
